Suppliers And Customers

Collection Of Personal Data by Way of Contract

We collect and process personal data about our suppliers (including subcontractors and individuals associated with our suppliers and subcontractors) and Customers in order to manage the relationship, contract, to receive services from our suppliers and to provide services to our clients.

Use Of Personal Data

We use personal data for the following purposes:

Supplier/Subcontractor Services

We hold and process personal data in relation to our Suppliers and Subcontractors as necessary only to receive and make payment for the services and to comply with the legislative regulations relevant to our Business.

Clients

We hold and process personal data in relation to our clients as necessary and only to fulfil contracted services. We do not share this information with others except where necessary to enable the fulfilment of our Contract.

Personnel

We collect personal data by way of contract concerning our own personnel as part of the administration, management, and conduction of our business activities. Personnel should refer to the Privacy Policy addendum to the Staff Handbook for information on why and how personal data is collected and processed.

Data Retention

We retain the personal data processed by us for as long as is considered necessary for the purpose for which it was collected (including as required by applicable law or regulation). Personal data may be held for longer periods where extended retention periods are required by law or regulation and in order to establish, exercise or defend our legal rights.

Security, Quality and Risk Management

We take the security of all the data we hold very seriously and have security measures in place to protect it.
